The pledge and its principles are in line with the objectives of the National Key Result Area (NKRA) of fighting corruption within the Government Transformation Programme (GTP).

MRCB recognises and plays its part in complying with laws, policies and procedures related to fighting corruption in a more transparent and accountable governmental operating structure, set against a backdrop of strong governance.
